A list of all homeowners who completed the form has been forwarded to our landscaper. Before they begin working, they will place a small flag on your property which helps them identify what services not to be completed on your property.

# DOGS OFF LEASH ON COMMON GROUNDS

Our office has been receiving an increase in complaints of people allowing their dogs off lease and also not cleaning up after their pets.

All dogs must be on leash at all times on common ground. You cannot just let them out your back door if you do not have a fence. Once your pet leaves your property, it is on common grounds and the rules apply.

If you are a homeowner in violation of the pet rules, you will receive a fine starting at \$100. The fine increases for each violation.

If you are a tenant, and you are in violation, your landlord will be notified and fined starting at \$100. The fine also increase for each violation. So please make sure your dog is on the lease at all time on common grounds.
